- 7. Breeder warrants that the above described puppy / dog is a purebred pug registered with the New Zealand Kennel Club.
- 8.To the best of the seller's knowledge and belief this puppy / dog is in good health and is free from symptoms of contagious and infectious disease at the time of sale / transfer.
- 9. The Buyer is responsible for any costs involved in shipping of a puppy / dog (air charges, transfer box, etc.), including shipping costs involved if the puppy / dog is returned for any reason. Furthermore Buyer responsible for the insurance on puppy / dog to transfer-time. The seller cannot assume to guarantee for injury, disease or any event during the delivery. Proper notice must be given before returning any puppy / dog for any reason to insure that Breeder will be available to pick up the puppy / dog at the airport. - 10.Buyer understands that a normal Pug can have medical abnormalities including but not limited to: elongated soft palate, small trachea, keratoconjunctivitus sicca, stenotic nares, hernias, sometimes skin problems (hot spots, demodectic mange, dermatitis), corneal ulcers. These abnormalities are in every breed and are treatable & curable with proper vet treatment, therefore, they are not covered by this contract's guarantee. The medical treatment of the pug requires specialized vet knowledge and experience. Buyer agrees to provide proper vet care and house in a manner that is acceptable for the health of this breed.
- 11. The Buyer shall notify Breeder first if for any reason the buyer no longer wants or is unable to keep the puppy / dog. Breeder shall have first right of refusal if the puppy / dog is to be sold or disposed of in any way. If Breeder does not wish to have the puppy / dog returned, Breeder will try to assist buyer in placing the puppy / dog if the buyer chooses.
- 12. The buyer is to inform Breeder of any show results, earned titles, the health, breeding results, and other results, and send photos at least in every 3 months.
- 13. Buyer agrees that he is not acting as an agent in the purchase or this puppy / dog and that Buyer will not sell this puppy / dog or its progeny to any agent, pet store or quard dog business.
- 14. The Breeder neither makes or implies any warranties or guarantees, expressed or implied, other than those written in this contract / agreement.
